The following points were discussed and finalized for code of ethics inside the campus and should be circulated to all staff and students.

- Perform their duties in the form of teaching, tutorial, practical, seminar and research work conscientiously and with dedication. Participate in extension, co-curricular and extracurricular activities.
- Encourage students to improve their attainments, develop their personalities and at the same time contribute to community welfare.
- Inculcate among students scientific outlook and respect for physical labour and ideals of democracy, patriotism and peace.
- Students will be subject to disciplinary action up to and including suspension or expulsion from the College if they engage in Student Misconduct.
- Student Misconduct Includes behaviour that: disrupts the teaching learning process, or interferes
 with the well-being of other students or employees, or causes damage to College property.
- 6. Student Misconduct also includes the following, but is not limited to: Assault, all forms of Bullying, all forms of Discrimination, including contributing to a Poisoned Environment, Disruptive, Threatening or Violent Conduct, Harassment, Mobbing, Sexual Assault, Sexual Harassment, Sexual Violence, Workplace Harassment.
- The Anti-Ragging Committee shall examine all complaints if anti-ragging and come out with recommendation based on the nature of the incident.
- 8. Vehicles are not permitted beyond the parking lot and students are advised to follow all precautions for safe driving, parking is the owner's risk and the college shall not be responsible for any loss or damages to their vehicles.
- 9. The concerned student will be held responsible for any violation of rules even if the vehicle is not driven by student. Entry and exit of vehicles will not be permitted without the driver(s) wearing helmet (two wheeler vehicles) and seat belts (Four-wheeler vehicles).
